General News:

Dr. Christina Delos Reyes, Addiction Psychiatric Fellowship, University Hospitals Case Medical Center, was interviewed for ABC news in Dayton on June 21st regarding House Bill 4, a bill designed to get better access to the heroin antidote -- naloxone -- is one step closer to becoming a law. It would allow doctors to give the authority to pharmacists to give out the antidote without a prescription. It would also give immunity from liability to friends and family who jump in to help an addict who overdoses. Opponents often fear the antidote condones or legitimizes heroin abuse but doctors argue it saves lives. “We do know that people who have their overdose reversed, approximately one-third will continue to overuse but two-thirds will actually take it as the wakeup call that it is and go into treatment,” says. No word on if or when Governor Kasich may sign the bill.

The Mood Disorders Program is currently enrolling adults aged 18 and older who are currently experiencing depression associated with bipolar disorder in to a clinical trial to test whether pioglitazone, a medication that improves the efficiency of how the body uses blood sugar, is able to reduce depression severity. Those currently receiving treatment may continue taking their medication. Participants cannot have a history of bladder cancer or heart failure and cannot be diagnosed with dementia or taking insulin or rosiglitazone. For more information, please call 216-844-2862.
